The Fund aims to have both a prospective yield at least 1.1x that of the Asia Pacific ex-Japan markets and to deliver long-term capital appreciation. Mark Williams and Carolyn Chan aim to achieve this through a four-stage investment process – identifying the key drivers for Asia Pacific (ex-Japan) equities, incorporating these into a framework to determine the likely beneficiaries and losers of these drivers, fundamental stock analysis to identify individual companies and portfolio construction. 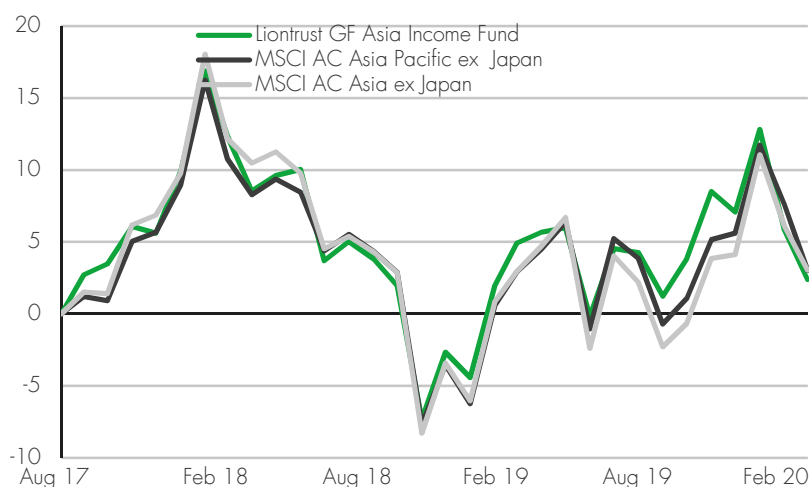
