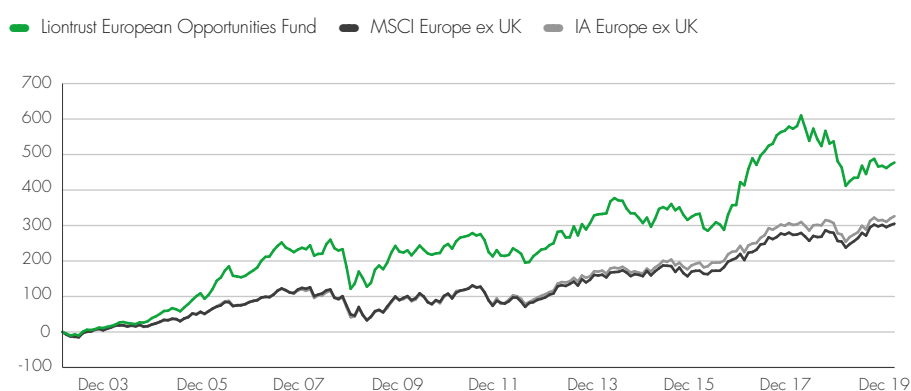
Strategy

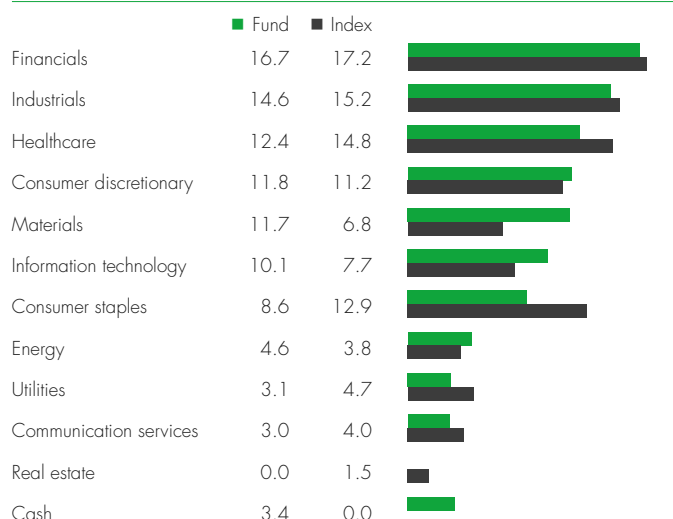

Income distribution

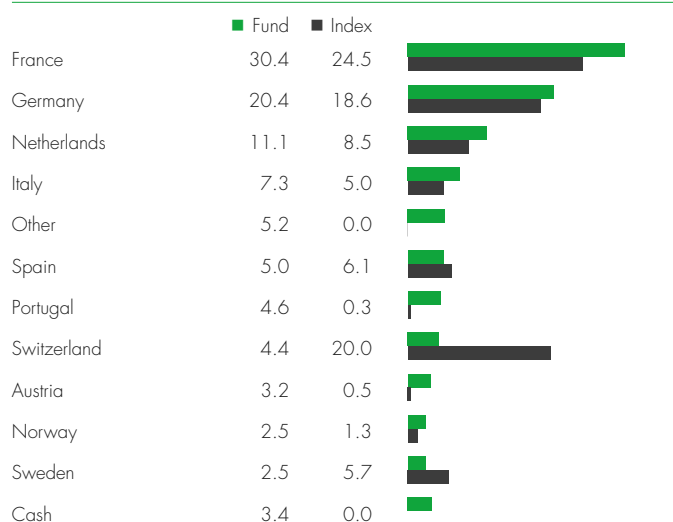
