The Fund

The Fund aims to provide a higher long term return than that provided by UK Government bonds. 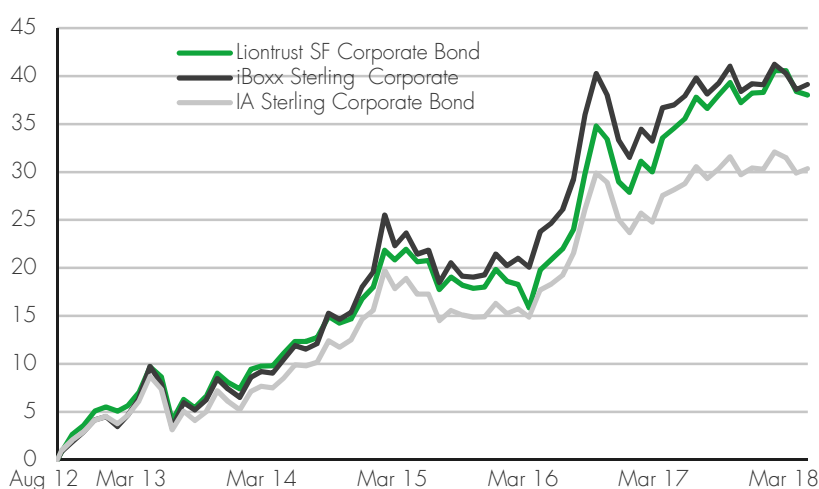

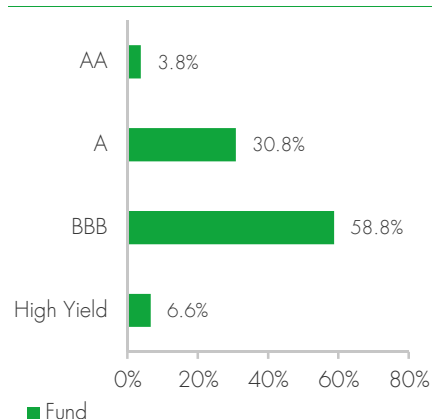
