Liontrust India Fund (the 'Fund') - ISIN: GB00B1L6DV51. A sub-fund of Liontrust Investment Funds I. Liontrust Investment Management Limited is the 'Authorised Corporate Director' of the Fund.

Objective and Investment Policy

Objective

- To generate long term (5 years or more) capital growth.

Strategy

- The Fund invests in a mix of companies that may provide growth opportunities, attractive valuations, or special situations. Special situations can exist where companies are out of favour, misunderstood or where management changes or takeovers are expected.

Investment Policy

- The Fund invests at least 80% in shares of Indian companies. These are companies which, at the time of purchase, are incorporated, domiciled, listed or conduct significant business in India. The Fund may also invest up to 20% in other companies outside of India, as well as in other eligible asset classes as detailed within the prospectus. The Fund Policy complies with the IA Specialist Sector guidelines. This index is a relevant potential performance comparator for investors because of the similarity of the investment universe.
- Any income the Fund generates will be reinvested to grow the value of your investment.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within five years.

Shares can be bought or sold on any working day in London.

The Fund is in Category 6 because of the high range and frequency of price movements (volatility) of the underlying investments referenced by the Fund.

The following are additional risks not covered by the risk and reward category.

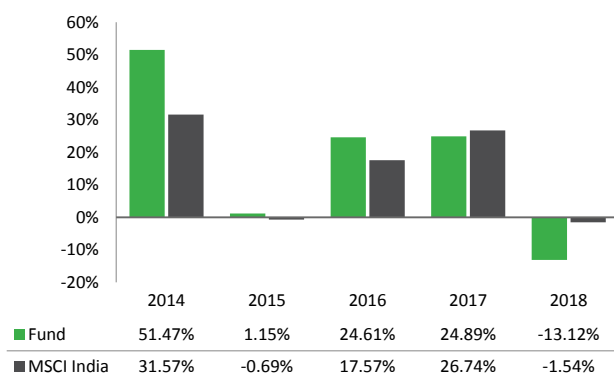
