

Durham and Liontrust agree partnership

Durham County Cricket Club and Liontrust, the specialist fund management company, have agreed an initial two-year partnership deal.

Notes for editors

Durham County Cricket Club's history began when it was established on 23rd May 1882, and they played their first match at Chester Road cricket ground. After just less than three years, the Test & County Cricket Board awarded DCCC first-class status in 1992. Durham became the first county to be granted such status for 70 years. The Club won its first piece of silverware in 2007 at Lord's in the Friends Provident Trophy final. In 2008 Durham County Cricket Club won the LV County Championship and the Second Eleven Championship, both for the first time in the Club's history. The first eleven went on to retain the Championship title in 2009 and then won it for a third time in 2013. The following year, Durham won the 50-over Royal London One-Day Cup in 2014. In 2010 the Club signed a groundbreaking sponsorship agreement with Emirates Airlines, with the company committing to be Main Club Sponsor.

Liontrust, which was launched in 1995, is a specialist fund management group whose shares are quoted on the London Stock Exchange. Liontrust has £10.6 billion in AuM (as at close of 31 December 2017) and was named Specialist Group of the Year at the Investment Week Manager of the Year Awards 2017. Liontrust has eight fund management teams: five that invest in UK, European, Asian and Global equities, a Global Fixed Income team, a Sustainable Investment team and one team that manages Multi-Asset portfolios.
