The Fund

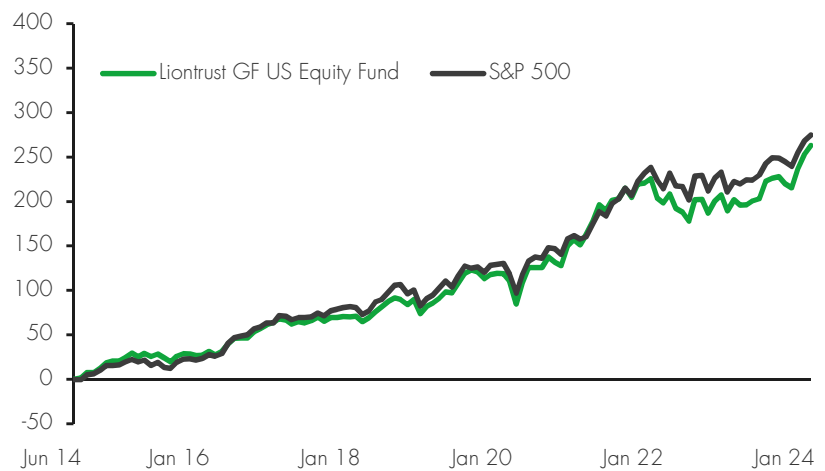
- The US Equity Fund is a high conviction portfolio, which invests at least 80% of net asset value in US equities.
