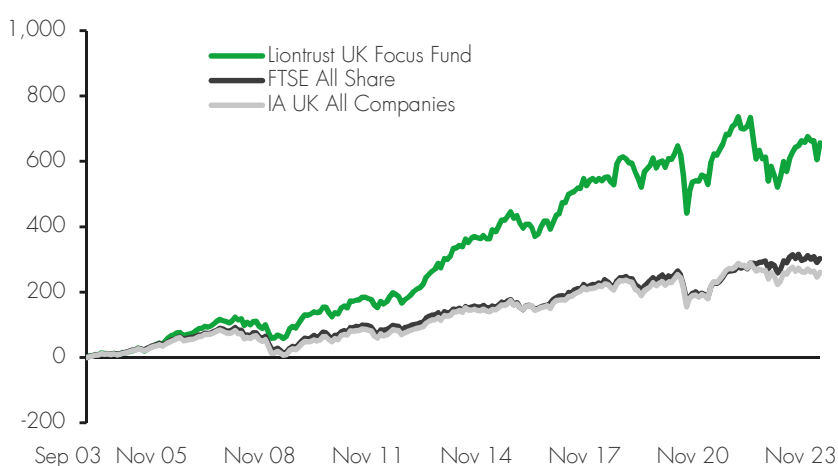
The Fund
