

Liontrust MPS Dynamic Passive 1

Objective and strategy

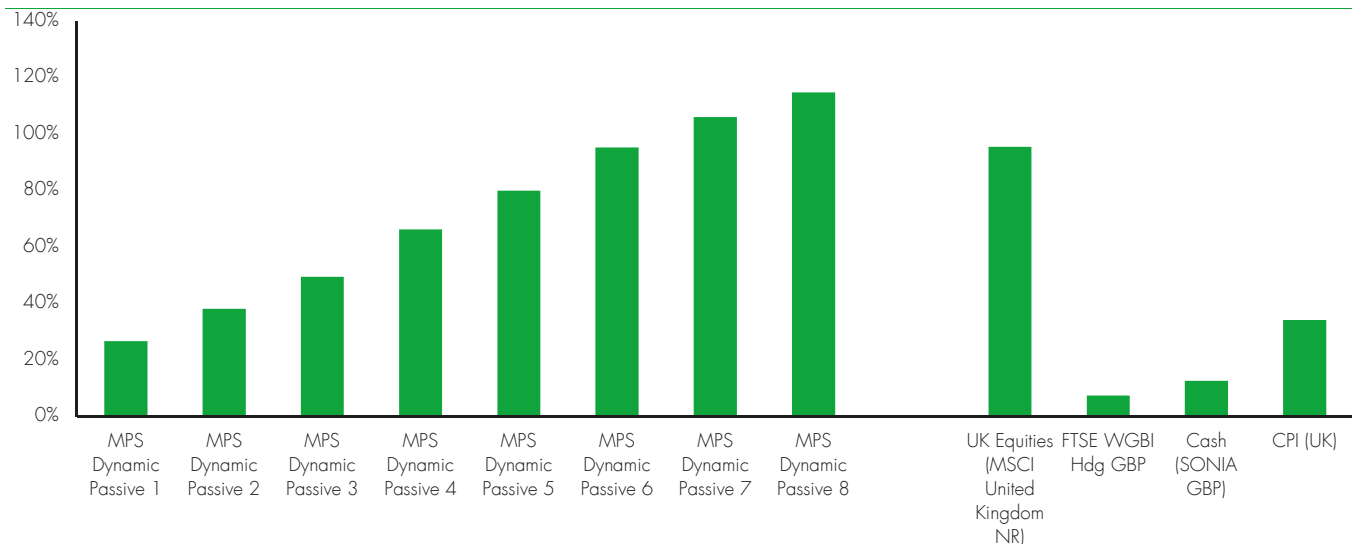
The portfolio aims to grow capital in line with the rate of inflation (CPI) over the long term (more than five years), with a low level of volatility and limited potential for capital loss (Please note that capital is at risk and you may get back less than you invested). It seeks to achieve this by investing around half the portfolio in cash and money market funds, with the rest usually allocated to fixed interest and equities. The majority of the equity allocation will be invested in developed markets. The portfolio may sometimes also have a small holding in alternative investment funds. The portfolio will predominantly, although not exclusively, use low cost beta strategies to invest. If these low cost beta strategies are unavailable, appropriate exposure will be taken via active management strategies.

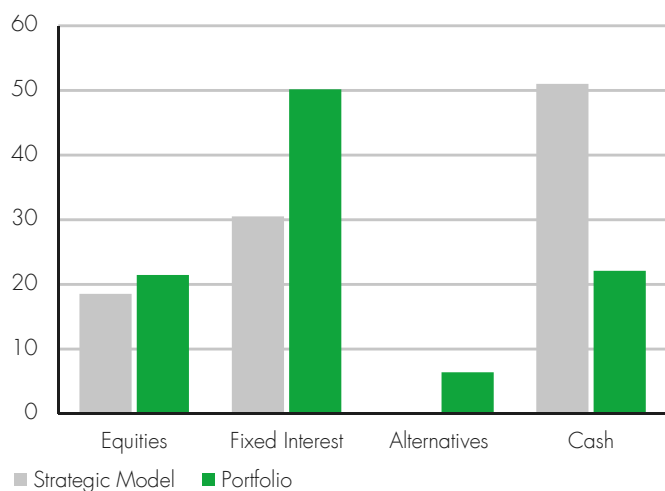
